<b>Monday, May 11, 2015</b>  <i>Deadline is extended because of weekend.</i>	<b>May monthly activities report</b>  (all lobbyists filing monthly)	April 1, 2015, <i>or</i>  January 1, 2015, if first activities report*	April 30, 2015
<b>Wednesday, June 10, 2015</b>	<b>June monthly activities report</b>  (all lobbyists filing monthly)	May 1, 2015, <i>or</i>  January 1, 2015, if first activities report*	May 31, 2015

\* If you file your initial lobby registration after January 1, 2015, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2015, that registrant’s first monthly report (due by April 10, 2015) would cover the period beginning January 1, 2015, and ending March 31, 2015. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

<b>Tuesday, October 13, 2015</b>  <i>Deadline is extended because of weekend and holiday.</i>	<b>October monthly activities report</b>  (all lobbyists filing monthly)	September 1, 2015, <i>or</i>  January 1, 2015, if first activities report*	September 30, 2015
<b>Tuesday, November 10, 2015</b>	<b>November monthly activities report</b>  (all lobbyists filing monthly)	October 1, 2015, <i>or</i>  January 1, 2015, if first activities report*	October 31, 2015

\* If you file your initial lobby registration after January 1, 2015, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2015, that registrant's first monthly report (due by April 10, 2015) would cover the period beginning January 1, 2015, and ending March 31, 2015. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***
